All bids must be accompanied by a sum of **Rs. 200,000/-** as bid security against each centre, on "As is Where Is" basis, in the form of Pay Order / Demand Draft/ Banker's Cheque issued by any scheduled Bank in Pakistan in favour of PASSCO. **Cash / Cheque / Call Deposit Receipt (CDR) / Security Deposit Receipt (SDR) / Bank Guarantee will not be acceptable and bid shall be rejected.**
- 3. Bidders can quote rates (inclusive of all taxes) of damaged wheat against each center. The maximum/ most advantageous rate quoted for a particular center during the bidding process by any party shall be used for the award of contract regarding selling/ lifting of the damaged wheat in that center. The bid security of the successful bidder shall be adjusted against his performance security on the award of contract.

#### **INTRODUCTION:**

PASSCO is a public limited company established in 1973 mandated to procure wheat as per the target set by the Federal Government, maintain a strategic reserve of 2.0 Million Metric Tons and then distribute it to the wheat deficit areas/ agencies as per allocations made by the M/o NSF&R. PASSCO has 13 x zones throughout the country to undertake the assigned mission.

#### **INSTRUCTIONS TO THE BIDDER**

- 1. Sealed bids addressed to Zonal Head Khairpur shall be received upto 1500 hours till 15.11.2023 in PASSCO Head Office Lahore and upto 1200 hours till 17.11.2023 in the Zonal Office Khairpur. All the bids received in Head Office and Zonal office Khairpur shall be opened in the Zonal office Khairpur, at **1230** hours on 17.11.2023 in the presence of bidders or their authorized representatives.
- 2. All bidders shall quote their rates in Rupees per Metric Ton on prescribed bid form. All bids must be accompanied by a sum of Rs. 200,000/- as bid security against each centre, on "As is Where Is" basis, in the form of Pay Order / Demand Draft/ Banker's Cheque issued by any scheduled Bank in Pakistan in favour of PASSCO. Cash / Cheque / Call Deposit Receipt (CDR) / Security Deposit Receipt (SDR) / Bank Guarantee will not be acceptable and bid shall be rejected.
- 3. Bidders can quote rates (inclusive of all taxes) of damaged wheat against each center. The maximum/ most advantageous rate quoted for a particular center during the bidding process by any party shall be used for the award of contract regarding selling/ lifting of the damaged wheat in that center. The bid security of the successful bidder shall be adjusted against his performance security on the award of contract.
- 4. Successful bidder will be required to deposit **5%** of the value of the contracted quantity as performance security alongwith signing of the agreement on stamp paper worth **Rs.3,000**/- duly purchased in favour of PASSCO at the time of offering of Acceptance Letter, failing which bid security deposited by the bidder shall stand forfeited.
- 5. The bidder shall provide an affidavit alongwith the bidding documents stating that the bidder has never been blacklisted by any government or agency.
- 6. The bidder/ company shall furnish the names and addresses of its partners or directors, if any.
- 7. Bid must be submitted on the prescribed bid form only. Bid on the Letter Head pad of the firm or telegraphic offers or bids delivered through any electronic media etc. shall not be entertained.
- 8. Bidder should clearly indicate name, address, telephone (Cell No), fax number and E. Mail address etc.
- 9. Each page of the bid document will be signed by Bidder appending full signatures, name and office stamp of the firm/party.
- 10. Bidder will put complete signatures on alterations and cuttings, if any made by him.
- 11. Offer will remain valid for **60 days** from the date of opening of the bid.
- 12. Offer will not be considered if: -

- a. Received without bid security;
- b. Received after 1500 Hours on **15.11.2023** at Head Office Lahore and after 1200 Hours on **17.11.2023** at PASSCO Zonal Office Khairpur.
- c. Bid is unsigned; and
- d. The offer is ambiguous or conditional.
- 13. If successful bidder withdraws or amends the offer within the validity period of the offer, bid security shall be forfeited.
- 14. Bidders must satisfy themselves regarding the quality, quantity and physical condition of the damaged stocks by inspecting the sites with effect from 01.11.2023 to 16.11.2023 (0800 to 1600 hours). No objection will be entertained after submission of the bid. Centre wise tentative quantity is as under:-

- 15. Successful bidders shall have to deposit in advance PO/ DD/ BC against the wheat stocks to be lifted and are bound to lift the entire contracted quantity within 45 days. Lifting order of at least 20 to 40 M Tons each will be issued by Zonal Head after confirmation by F&A Wing of the deposit of stock's cost through PO/ DD/ BC. If successful bidder fails to lift the contracted quantity within 45 days, then a penalty @ 2 % shall be imposed for subsequent delay upto 15 days against un-lifted stocks. Thereafter, agreement will be rescinded & the total bid/ performance security and any amount, deposited in this regard, will be forfeited. No extension whatsoever on any ground shall be granted beyond 60 days.
- 16. In case of partnership, photocopies of CNICs of the partners must be enclosed with seal bids.
- 17. Terms and conditions of bid notice and those elucidated in this bid document will be substantial / integral part of agreement/ contract.
- 18. The bidder will be strictly bound to lift the damaged Wheat stock within the stipulated period as mentioned in the agreement.
- 19. The Competent Authority of PASSCO may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

### 20. **FORCE MAJEURE**

- 20.1 Force majeure shall mean any event, act or other circumstances beyond the control of the PASSCO or of the Bidding Firm i.e., Earthquake, Flood, or any other severe climatic circumstances. Non-availability of logistical materials or items ancillary to such material or any other event called by clear negligence of the bidder shall not constitute Force Majeure.
- 20.2 In the event that a Force Majeure situation arises, the firm shall inform to PASSCO through written notice as soon as reasonably possible and indicate the condition and

cause thereof, unless otherwise directed by PASSCO in writing, the firm shall continue to perform the lifting of the stocks as far as is reasonably practical and shall seek all reasonable alternative means of performance by mitigating the effect of Force Majeure. In the event that the stocks cannot be lifted due to Force Majeure, the time for lifting of stocks may be extended by MD PASSCO on a case to case basis.

20.3 The firm shall not be liable for liquidated damages, forfeiture of its Performance Security, blacklisting for future tenders, termination for default, if and to the extent of his failure/ delay in performance/ discharge of obligations resulting from an event of Force Majeure.

# 21. **Arbitration:**

In case of any difference or dispute between the parties arising out of this agreement or in the matter enumerated therein, the same shall be referred to the sole arbitration of the **Managing Director** for the time being of Pakistan Agricultural Storage and Services Corporation Limited (PASSCO) or any person nominated by him whose award shall be final and binding on the parties to this agreement. The arbitration shall take place in accordance with the Arbitration Act, 1940 and the venue for Arbitration shall be Lahore.

# 22. **Jurisdiction of Court:**

Regarding the issue of jurisdiction in case of litigation between parties hereto, the Courts at Lahore shall have the exclusive jurisdiction to entertain resultant disputes.
