OPEN AUCTION - TERMS & CONDITIONS

PASSCO offers C & D category dead stock items i.e. Tarpaulins, Gunji Kits, Bardana, Polythene Sheets, PP bags, Rope, Silver bottles, Rags, Tat / Patri and junk store items etc. for sale through Open Auction on "as is where is" basis. The items are lying at different places of PASSCO Field Zones i.e Hafizabad, T.T Singh, Sahiwal, Vehari, Khanewal, Multan, Bahawalnagar, Alipur, Khanpur, Layyah & Khairpur. The terms & conditions are as under:-

- a. The auction will be on "as is where is" basis.
- Stores / items to be sold will be placed at respective PC/RV / Godowns. List
 of locations/ PC/RVs and stores / items is held with respective Zonal Offices.
- c. Bid offered for the auction will be valid for 30 days.
- d. Bidders are required to deposit bank draft / pay order on account of bid money (refundable as mentioned in para-2) in favour of PASSCO alongwith a written request with copy of CNIC for participation in open auction. Bid money can also be deposited in cash before commencement of auction.
- e. Acceptance of bid / letter will be issued after obtaining the approval of Competent Authority. The highest / successful bidder will sign the agreement on stamp paper worth Rs.100/- within 3x days of acceptance of bid and deposit 10% security (including bid money) within 7x days of signing the agreement.
- f. Lifting period of stores will be 30 to 45 days from the date of signing of agreement, keeping in view the quantity / volume of the store.
- g. The successful bidder will deposit the cost of store / items to be lifted in advance before lifting
- The successful bidder will be bound to lift items from all PASSCO Centres at his own cost.
- Applicable tax (presently 10%) will be paid by the bidder in advance alongwith cost of items.
- j. Bid money of the unsuccessful bidders will be refunded immediately after conclusion of auction process. However, security deposited by successful bidders will be refunded / adjusted when entire quantity of stores is lifted within stipulated period.
- k. If the successful bidder fails to lift the auctioned stores within specified period, security money deposited by him will be forfeited by PASSCO.
- I. PASSCO reserves the right to accept or reject any or all bid (s).
