6. Bidding documents should accompany a Pay Order or Bank Draft issued by any Scheduled Bank equivalent to 2 % of Bid money in the name of "**PASSCO**", as Earnest Money. No CDR will be accepted.
7. Time period of the project in each zone will be upto 365 days after the issuance of work order.
