#### **TERMS AND CONDITIONS**

1. Offer must be made on proper Tender Form. Lowest bid / successful tender will be signed by Zonal Head and tenderer and kept with Zonal Office for any reference at later stage.
2. Offer should be accompanied by Earnest Money @ 3% of total bided cost against annual requirement (Page-6 of T&Cs) in shape of Bank Draft/Pay Order in favor of PASSCO. The successful tenderer will be required to furnish security/Performance Bond @ 5% of the contracted value (including Earnest Money) within 05 working days of the placement of letter of acceptance in the form of Bank Draft/Pay Order, in favor of PASSCO and the same will be refundable on successful completion of contract to the supplier on his specific request.
3. Tender must be submitted on the prescribed tender Form (issued by PASSCO).
4. Tender on letter head pad of the firm or telegraphic offer or through any electronic media, will not be considered.
5. Contract will be for a period of 12 months.01.02.2024 to 31.01.2025 and extendable for one more year.
6. Late receiving bids after due time and date will be rejected and returned to the bidders unopened.
7. No alteration or amendment will be allowed in any case at the time of bid opening.
8. All prices must be quoted in Pak Rupees and should include any Taxes applicable, GST, Income tax etc. If not specifically mentioned in the offer, it will be presumed that the prices include all the taxes. Any subsequent change in tax regime would be adjusted accordingly.
9. Tenders received through any other mode/addressed to any other person will not be entertained.
10. The Competent Authority may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under PPRA Rules. The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
11. Bid be rejected for if:-
  - a. Received without Earnest Money as required.
  - b. Received after 1030 hours on 20 .01.2024.
  - c. Tender is unsigned.
  - d. The offer is ambiguous or conditional.
  - e. If not submitted on PASSCO issued prescribed tender forms.
12. PASSCO management reserves the right to accept or reject any offer/tender or modified, curtail, enhance the quantity offered, ignore, scrap, cancel all tenders prior to award of contract, without thereby incurring any liability or obligation to inform to tenderer.
13. If a tenderer withdraws or amends the offer within the validity period of the offer, his Earnest Money/ Bid Bond shall be forfeited.
14. Successful tenderer will be required to execute the contract after fulfilling all the requirements within 10 working days after the date of issuance of acceptance letter in accordance with the terms and conditions

### **SPECIAL INTRUSCTIONS**

16. Each page of the tender document i.e. tender form will be signed by tenderer appending full signature and name.
17. Alterations and cutting will be authenticated under full signatures and name of the tenderer.
18. Tenders should be addressed to respective Zonal Head PASSCO.
19. Tenders will be submitted in single cover. It should indicate name of the addressee and marked With "TENDER FOR SUPPLY OF DRY RATION FOR PASSCO ZONE ON DELIVERED BASIS.
20. Requirement will be made on monthly basis as indicated in tender notice which may be fluctuating.

### 21. **FORCE MAJEURE:**

The right of PASSCO to terminate the contract, or to claim penalty or liquidated damages shall be subject to the following Circumstances, provided as a result of all or any of these events there has been delay in the performance of the contract by the service provider, or the contract has become incapable of being performed:-

- a. Act of God.
- b. Act of State, War or any Act of the Enemy.
- c. Lock outs, Riots or Civil Commotion.
- d. Injection granted by a Court of competent jurisdiction not resulting from any fault of the service provider.

### 22. **FAILURE / TERMINATION.**

- a. If you fail to deliver the ration articles of specified contracted quality or any consignment thereof within the specified delivery period, the purchaser shall be entitled at his option either:
  - i. To purchase from elsewhere without notice to you at your risk and cost, the stores not delivered, without cancelling the contract in respect of the consignment not yet due for delivery.
  - ii. To cancel the contract at your risk and cost.

In the event of action being taken under (1) or (2) above, you shall be liable for any loss which the purchaser may suffer on the account, but you shall not be entitled to any gain on repurchase made against the supply order.
