

## INVITATION TO BID

### SALE OF 13,200.267 METRIC TONS (± 15%) DAMAGED WHEAT

Pakistan Agricultural Storage & Services Corporation Limited (PASSCO), a Public Limited Company invites sealed bids from interested parties/firms for the sale of **13,200.267** Metric Tons (± 15%) of damaged wheat (**Unfit/ not safe for human consumption**) on “**As is Where is**” basis, **lying at different locations of PASSCO D.A.Yar Zone (Baluchistan)**, subject to the conditions laid down in bid document. The contract resulting from this invitation to bid shall be governed by the terms and conditions outlined in the bid document. The bidder shall be deemed to have read and understood the conditions thereof and particulars of the material mentioned above.

2. All bidders shall quote their rates (Inclusive of all taxes & duties) in Rupees per Metric Ton on the prescribed bid form. All bids must be accompanied by a sum of **Rs. 1,000,000/-** as bid security against each lot, on “**As is Where Is**” basis, in the form of Pay Order /Demand Draft /Banker’s Cheque issued by any scheduled Bank in Pakistan in favour of PASSCO. **Cash /Cheque /Call Deposit Receipt (CDR) /Security Deposit Receipt (SDR) /Bank Guarantee will not be acceptable and the bid shall be rejected.**
